EFSM Mission

To empower, provide support, advocacy and guidance to women who are involved in the legal system

Canadian Association of Elizabeth Fry Societies Mission

CAEFS is an association of self-governing, community-based Elizabeth Fry Societies that work with and for women and girls in the justice system, particularly those who are, or may be, criminalized. Together, Elizabeth Fry Societies develop and advocate the beliefs, principles and positions that guide CAEFS. The association exists to ensure substantive equality in the delivery and development of services and programs through public education, research, legislative and administrative reform, regionally, nationally and internationally.

Enhancing the Self-Worth of Women in the Criminal Legal System

The Elizabeth Fry Society of Manitoba Inc was established as an independent non-profit organization in 1983 to address the unique needs of women and female youth in the provincial and federal justice system.

We provide advocacy, access to resources and support to families of women who are in conflict with the law. Some of the issues our clientele struggle to overcome are addiction, poverty, mental health issues, marginalization, racism, long-term effects of residential schools and other forms of discrimination.





Some of the programs and resources we offer include:

- **Bail Verification and Supervision Program** provides community supervision and support to women who are charged with offences. The Bail program serves the principles upon which our democratic system of justice is based: the presumption of innocence and the fair and equitable treatment of all people regardless of social or economic background.
- Women for Change created in response to the Manitoba Government's Zero Tolerance policy as a mean of dealing with rise in numbers of women charged and convicted of domestic violence. The program deals with women as abusers. Women are given the tools and knowledge to cope with their anger in a positive nonviolent manner. It's a 10 week program running 3 times a year fall, winter and spring. The program looks at: the cycle of violence, safety plans, anger management techniques, human emotion, socialization of men and women and the impact of violence on children.

STOPlifting – for women who have or had committed shoplifting, fraud and other breach of trust offences in Winnipeg. The project works to reduce the risk of recidivism and promote a healthier lifestyle though individual and group support programming and community accountability. To ensure women and girls learn and practice new methods of dealing with our shoplifting, fraud and breach of trust offences in a safe and non-judgmental environment.

Transitional Housing – offering a supportive living arrangement for four to six women by bridging the gap between homelessness and independent living. EFSM will offer women a chance for successful reintegration, an opportunity to work on education, employment literacy, health and other identified objectives, as well as access to services. The above are done in an environment that nurtures the women's individuality and potential for success. **Reading Stories Project** - The purpose of the project is to give women an opportunity to connect with their children through reading fictional stories using their voice. These readings are recorded and a copy of the recording and fictional story book is sent to the mother's child.

Clothing Depot – 'Release packages' to women who have recently been released from the Winnipeg Remand Centre, provincial and/or federal institutions. Often, women who are incarcerated at The Winnipeg Remand Centre or Portage Correctional Centre have only the clothing they were wearing at the time of arrest. If there has been a change of season, the women will have inappropriate seasonally based clothing (re: summer clothing in winter); and to assist women with very practical needs when they are released from The Winnipeg Remand Centre, provincial and/or federal institutions. These practical needs are providing some clothing, some hygiene products (if available) and a few household items on an ad-hoc basis.

• The Womens' Books for Prisoners Project – The books are donated from the community and university students. The books are vetted for the following exclusion criterion: no hard cover books, true crime stories, and no positive stories of gang and criminal involvement. These books are then distributed to Portage Correctional Centre, the Winnipeg Remand Centre, The Pas Correctional Centre and the Manitoba Youth Centre.

EFSM...

Specifically focuses on women who are at risk at becoming, or have been involved with the legal system. We also province of Manitoba upon their release.

According to the Canadian Association of Elizabeth Fry Societies:

We aim to increase the availability of community-based, publicly funded, social service, health and educational resources available for marginalized, victimized, criminalized and imprisoned women.

A big welcome to new staff, Len Duchon, manager of the Bail Verification and Supervision Program and Kevin Johnson and Jo-Anne Pelletier, bail workers. They have been working hard to ensure their program runs efficiently and effectively for women on interim judicial release.

Also welcome to **Tina Chartrand**, Community Liaison and Housing Coordinator. She has done phenomenal work and is a great addition to the team

New Programming

The Bail Verification and Supervision is a very busy program through Manitoba Justice. Staff visit women at Remand Centre, interact with lawyers, attend court and write reports for Court. They also work to support the women while in the community to ensure they meet the conditions of their judicial release. They do this by making referrals to other programs related to substance use, domestic violence and anger management counselling and/or general counselling related to unresolved issues that may be hindering their progress in building a better life.

Our Community Outreach Program is always our most public and innovated programming. Just to name a few services the Outreach Program offers: Networking with partner and neighbouring organizations and canvassing for donations, visiting women at Psych Health PX3 at Health Sciences Centre, Winnipeg Remand Centre and Portage, the Literacy Program at all facilities, furniture referrals for women who need assistance in setting up their new homes, addiction treatment, Book Drives, coordinating and recruiting volunteers. The list is by no means exhaustive but highlights the value our programming has in the community.

Conclusion

EFSM is still in a transition mode, but moving forward in a positive way. Every credit goes to the hardworking and caring staff of EFSM. We hope to continue our work in advocating and supporting of our many clients.

Report by the Executive Director Tracy Booth

- We see women who have criminal records and this is a barrier to securing employment.
- We see women whose only life experience is institutional: child welfare, group houses and youth correctional facilities.
- We see women who do not physically see their children while they are incarcerated: remanded, provincial or federally sentenced.
- We see women who struggle to find housing, and to maintain housing.
- We see women who have multiple barriers to being able to meet their basics needs of food, clothing and shelter.
- We see women who have lived in the residential school system whose culture, language and way of being were eradicated.
- We see women whose parents and grandparents have lived through the residential school system whose culture, language and way being were eradicated.

Some highlights of 2008 include:

- Our struggle with a management turnover. Despite this challenge, we continue to weather this storm, and to focus on position and effective transitions and programming. Our statistics prove that not only did we persevere, but we grew and expanded our supports to the community.
- A change in leadership. The Elizabeth Fry Society of Manitoba said good bye to Executive Director, Margaret Marin, and wishes her well in her future endeavours. I was honoured to step into this role in October 2008.
- Quality programming and services. I would like to take this opportunity to offer my gratitude to the staff in 2008. EFSM staff continues to provide services to women who often represent the most socially excluded women in the community.
- Exceptional volunteerism. With the Community Outreach Worker/Volunteer Coordinator to offer guidance, orientation, and support, our volunteer program continues to grow. To our volunteers and students in 2008, you are an important part of our team with value beyond measure.
- Strengthening of funding. To all our funders, thank you for empowering us to do our good work, and for believing that we can and do make a difference in our community.
- Community involvement, awareness and support. To our special donors, including the retail businesses who support our clothing depot, and the community members who collect travel sized hygiene items and donate them to our Elizabeth Essentials, while some may see these as small acts with little impact, I can advise otherwise. The dignity associated with receiving a hygiene products a, and finding a clean change of clothes makes our community donors and supporters true heroes.

Throughout all of the challenges, changes and successes of 2008, the Elizabeth Fry Society of Manitoba stayed focused on our mission to advocate on behalf of criminalized women in Canada, particularly, in Manitoba. I look forward to continuing this positive momentum into 2009.

Treasurer's Report Cheryl Stapleton

The Elizabeth Fry Society of Manitoba Inc. continued to finance the fallout of staffing issues during the course of its March 2009 year end. The period April 2008 to March 2009 had EFSM paying out severance wages of approx \$15,000 while it also engaged the services of a temporary Executive Director. The staffing issues also required legal services which cost the agency an additional \$20,000 over and above what it might otherwise be paying out for such services. The loss of \$53,000 being reported on the internal financial statements is representative of those two noted expenses plus certain programs ran over budget. We are going to investigate these programs to ensure that we have received the entire amount of the grants pledged prior to the final financial statements being issued. We are indebted to the United Way for continuing to provide us with the means to continue the programs that are so vital the success of this agency and a special thanks to our program funders for granting us the funds required to run the programs that our women need.

Program Highlights

<u>Community Outreach/Clothing Depot/Volunteer Coordinator – Heather Bristow</u>

My position is recruiting and coordinating volunteers, and assisting women who are reintegrating into the community from the criminal justice system, or have dealt with their charges and are in the community access resources and peer support to help provide a healthy and positive transition with finding resources such as food banks, shelters, education and employment supports, parenting and addiction programs, etc, and access to "Elizabeth's Essentials" (Clothing and Household Items Depot).

Services for Women who are incarcerated

- Prepare and send packages of clothing to women incarcerated at the Winnipeg Remand Centre (WRC), Portage Correctional Centre (PCC), Okimaw Ochi Healing Lodge (OOHL), Edmonton Institute for Women (EIFW), and to women in PsycHealth Centre PX3 Forensic Psychiatry Unit (PX3) at The Health Sciences Centre
- Support and access resources for women who are incarcerated at WRC, PCC, OOHL, EIFW, and to women in PX3
- Literacy supports are offered weekly to the women in the WRC, both a group program and one on one tutoring. Math and spelling worksheets are mailed out to women in PCC by request on an ongoing basis. In partnership with Winnipeg Anarchist Black Cross (ABC), Recording Stories Project-"Tell me a Story" is offered weekly in WRC and PX3. This Project gives women an opportunity to connect with their children through fictional stories using their voice. The Women's Books for Prisoners Project is offered on an ongoing basis to women in all correctional centres across Manitoba and PX3.

Services for Women in the Community

- One on one support for women in need, and who are in conflict with the law
- Support and assist women with finding resources and programs, such as food banks, shelters, education, employment, parenting, addictions, etc.
- Access to Elizabeth's Essentials (Clothing and Household Items Depot)

Networking with partner and neighbouring organizations, committees and groups, and Manitoba Justice is a focus, as well as canvassing for donations. New mediums and potential new donors are frequented. Promotional material is often distributed to partner and neighbouring agencies, which allows for many women to request and access services.

Volunteer Program

- Women help organize and maintain Elizabeth's Essentials, sort through donations and assist in selecting clothing for the women
- EFSM volunteers are facilitating a weekly Literacy Program Group, which is well attended, and offering individual tutoring with women in WRC. Group work consists of writing and art expression, and numeracy.
- Women help prepare Care Packages for the holidays, such as Christmas and Mother's Day, and Release Packages to women coming out of incarceration

This year, the volunteer program has grown. Several women expressed an interest in volunteering with EFSM in all program capacities such as, co-facilitating community-based programs and the Literacy Program, office support; in the Community Outreach Program, the Provincial Reintegration Coordinator and Bail Supervision and Verification Program.

Provincial Reintegration Report – Marcie Tavares

The role of the Provincial Reintegration Coordinator is to provide in-person support, counselling, pre-release, follow- up services and advocacy to remanded and sentenced women incarcerated in the Winnipeg Remand Center and Portage Correctional Center. Women can access me through the toll free 1-800 telephone line for these services.

Women coming in the community from incarceration have priority in community counselling and support services. Empowering the women through our services helps them begin their healing journey. However, women in conflict with the law can access this service even though they have not currently come out of an institution.

Winnipeg Remand Center: I attend the Remand center every Wednesday afternoon from 1:00 till 3:00. The women's floor has 2 units. I spend an hour on each unit with the women. During this time we do activities on self esteem and culture. This gives me an opportunity to discuss EFSM services with the women.

Portage Correctional Center: I attend PCC the first and third Tuesday of the month. I am able to meet the women and work together with their pre-release plans. This gives the women an opportunity to establish a rapport with me before they are released. I assist the women with

making first contact with Employment Income Assistance (EIA), access to our clothing depot and support their initial contacts with their children and community agencies. Most importantly, I assist women with connecting to positive social network agencies or resources. I advocate on their behalf with Employment and Income Assistance, Child and Family Services, probation officers and lawyers, etc.

Community Women: When women are released from the WRC and provincial institutions, I continue to work with them in the community. Examples of this are, meeting the women at the bus depot from provincial institutions. Their first contact is with me and together we are able to arrange EIA appointments, Winnipeg Harvest appointments and CFS appointments. I also provide transportation to and from probation appointments, court hearings and programs within the community. In this way, I am able to assist the women with their various needs from other social service agencies which will facilitate with their reintegration back into the community.

Community Liaison/Housing Coordinator - Tina Chartrand

The Elizabeth Fry Society of Manitoba provides women who are released from provincial and federal institutions with two, two bedroom on-site transitional housing units. The purpose of these units is to offer safe, temporary emergency housing, as well as to connect women with supports and assist in recovery and reintegration.

The tenants can reside in transitional housing for a period of up to six months. Throughout this time I work with the tenants to find permanent, safe and secure housing. I also provide community and incarcerated women with low-income housing applications to various organizations, and advocate for safe housing on their behalf.

While living in our units the have a chance to take programs that we provided on site such as:

- Ladies AA group Beading Classes
- Women for Change (Anger management) Life skills training

The women who stay in the transitional housing units have the opportunity to receive individualized support to help each of them deal with her particular issues. I try to help each woman develop the skills to live a safe, healthy life for themselves and their families.

Finding housing continues to be a challenge because to the shortage of safe housing and the long waiting list for low income housing.

• I visit the Portage Correctional Centre and the Winnipeg Remand Centre to speak to women about their housing needs upon release. This is an excellent opportunity for the women and me to become familiar with one another. The relationship I establish with them assists me with learning about and assessing their needs upon release to our housing or into the community.

<u>Bail Verification and Supervision Program – Len Duchon, Jo-Anne Pelletier and Kevin</u> Johnson

The Bail Verification and Supervision Program provides community supervision and support to women who are charged with offences. The Bail Program serves the principles upon which our democratic system of justice is based: the presumption of innocence and the fair and equitable treatment of all people regardless of social or economic background. The goals of the Bail Program are:

- To reduce the number of pre-trial and pre-sentence women who are being remanded into the province's overcrowded correctional facilities.
- To reduce the risk of recidivism and promote a healthier lifestyle through individual and group supports programming and community accountability.
- To ensure that the women understand the expectations of bail, their legal rights and obligations.
- To connect women to the community programs and services that are available and needed by the women to comply with conditions of bail;

I have three degrees: Bachelor of Applied Science from the University of Guelph in 1986, Bachelor of Social Work from York University in 1999 and a Master of Social Work from the University of British Columbia in 2003. It is my hope to pursue a PhD location and thesis topic (topic still to be determined). As well, I have a Family Mediation Certificate from the University of Toronto in 1999.

I am also an auntie raising an 11 year old boy from Long Plain First Nation with the care and support of his uncle.

Shawn-Marie Tole Office Manager

I have been married for 20 years and have a 22 year old son and 11 year old daughter, as well as a self-absorbed Siamese cat named Fergus.

I have a varied career background in administration and Human Resources. I have served in the Canadian Naval Reserve, owned my own business, been a Recreation Director in a small Manitoba Interlake community, an Executive Assistant while working at a prominent business furniture company in Winnipeg and worked in the hospitality industry in Lake Louise, AB, London, ON, Gimli, MB and Winnipeg. I am very familiar with non-profit organizations as both a board member and as an employee.

I enjoy being physically active and pass that joy along by being a certified fitness instructor with the Manitoba Fitness Council, a certified Stott Pilates instructor and a certified Zumba instructor.

I trust the value and benefits of self-care in a mental, physical and spiritual sense and believe strongly in the work of EFSM. Redeveloping a program (Community Outreach) that had not been operating for two years was thrilling, and having women access it was even more exciting. I began my position at the Elizabeth Fry Society of Manitoba in April 2009 as the Community Liaison Coordinator which I enjoy greatly.

1. PURPOSE OF ORGANIZATION

The Elizabeth Fry Society of Manitoba Inc. is a non-profit community agency aimed "to empower, provide support, advocacy and guidance to women who are involved in the legal system."

2. SIGNIFICANT ACCOUNTING POLICIES

Capital Assets

The cost of capital expenditures has been expensed in the year of acquisition. These Capital expenditures are accounted for on the balance sheet with an offsetting entry to Invested in Capital Assets. The Society does not record amortization.

Income Taxes

As a registered charitable organization, the Society is exempt from income taxes under Section 149(1) of the Income Tax Act.

Pledges

The Society does not record pledges of contributions.

Donated goods and services

In common with organizations of this nature, the Society is the recipient of volunteer labour, the value of which is not recognized for accounting purposes.

Goods and Services that are normally purchased by the Society, but which are donated, the fair market value of such goods and services is recorded in the accounts. No such donations were received in 2009 or 2008.

3. GRANTS

The Canadian Association of Elizabeth Fry Societies receives grant funding from the office of the Solicitor General of Canada for distribution to the local societies. Of the 2008 – 2009 grants, \$8,218 was allocated to The Elizabeth Fry Society of Manitoba Inc.

4. ECONOMIC DEPENDENCE

The Society is economically dependent on the United Way of Winnipeg and the Province of Manitoba for grants to fund operations.
